Pradip Singh Chautala, the independent MLA in BJP's Singh Saini Cabinet—has resigned from the Vidh Sabha after joining the JJP—has resigned from the Vidh Sabha after getting the ticket from the party. Though he declared his resignation is "verified" by Bahadur Singh Chautala, the party said, "The resignation through a messenger. A has not appeared in the constituency. It is for us to verify that resignation has not been tendered under any pressure, Party compulsion."

He explained that his office in the constituency is exercising caution by not immediately and taking time to verify since in 2022, various Independent MLAs signed only to withdraw their candidature. He had resigned on the grounds of threat to life and subsequently retracted. "We were sure that the member would be so willingly," he said. "There is no time limit set for the verification" of the resignation under the rules, stating that it is unlikely to be accepted before the party.

The resignation came through a messenger. The MLA has not appeared in person. It is for us to verify that the resignation has not been sent under any pressure, threat or compulsion.

liamentary elections are over on June 4.

This assumes significance because Chautala is the only Independent MLA accommodated in the Saini Cabinet. Accepting his resignation could mean a vacancy in the Cabinet. With six of seven Independent MLAs supporting the Saini government "unconditionally", dropping Chautala would mean that another Independent MLA would have to be selected to replace him.

While Chautala is the senior-most Independent MLA, any vacancy would mean that the BJP would have to choose from among the remaining five Independent MLAs. This could lead to disgruntlement among others, something the BJP can ill-afford since it snapped ties with the JJP.
