With six of seven Independent MLAs supporting the Saini government "unconditionally", dropping Chautala would mean that another Independent MLA would have to be selected to replace him.

While Chautala is the seniormost Independent MLA, any vacancy would mean that the BJP would have to choose from among the remaining five Independent MLAs. could lead to disgruntlement among others, something the BJP can ill-afford since i snapped ties with the JJP.
