Important Notes:-

1. The Practical Examinations of Reappear students shall be conducted in their respective Colleges of which they were regular students.

2. While submitting TA/DA Bills, the Practical Examiner must be required to clearly mention their full name, designation with Grade Pay, Name of College, Name of Course with Semester and Session and same may be submitted to the Accounts Branch of the University directly.

3. IT IS MANDATORY FOR THE COLLEGES TO CONDUCT VIDEOGRAPHY AND THAT TOO AT THEIR OWN LEVEL (EXPENDITURE FOR THE SAME WILL BE BORNE BY THE CONCERNED COLLEGE/INSTITUTE ITSELF).
