Consultation with UPSC is not required for selection of Economic Officer.

and possessing the essential educational qualifications and experience and having successfully completed 2-4 weeks of training in the field as specified by NITI Aayog, will also be considered alongwith the outsiders and if a Departmental Economic Officer is selected for appointment to the post, it will be treated as having been filled by promotion.

NOTE:- The Departmental Research Assistant of the NITI Aayog in level-6 in pay matrix with five years service in the grade rendered after appointment thereto on a regular basis and having completed successful training of 2-4 weeks will also be considered alongwith the outsiders and if a Departmental Research Assistant is selected for appointment to the post, it will be treated as having been filled by promotion.

Age Limit

The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date for receipt of applications.

Period of Deputation
