**Item No. 1:** The Committee considered the mode of admission of various MBA programmes for the academic session 2016-17 and it was unanimously resolved to recommended that the admission to 2-Year MBA(Gen/BE/Hons.) programmes will be made through University Entrance Examination and 5-Year MBA integrated programme will be made on the basis of Academic merit of qualifying examination.

**Item No. 3:** The Committee considered the issue regarding admission to 2-Year MBA (Gen), 2-Year MBA (Hons.) and 2-Year MBA (BE) and it was resolved that the candidate will fill up only one Entrance Examination form by treating all the aforesaid courses as one programme and admission will be made in order of merit and in order of preference of the candidate at the time of

counseling for the MBA course subject to the fulfillments of required eligibility conditions for concerned programme

**Item No. 4:** The Committee considered the issue regarding the eligibility of Dr. Nidhi, Assistant Professor, UILMS, Gurgaon and after verifications of her documents it was resolved that she is eligible for supervising the Ph D scholar in Management.


