Prof. Dr. Rajbir Singh, Honorable Vice-Chancellor MDU Rohtak visited MDU-CPAS, Gurugram on Feb 23, 2019. Director MDU-CPAS Professor Santosh Nandal and Faculty Members welcomed the Hon. Vice Chancellor with bouquet of flower.

Vice Chancellor interacted with faculty members of both the department's law as well as management at length on the opportunities and initiatives for making the Centre as a institute of quality and excellence. Professor Rajbir Singh while interacting with faculty highlighted the importance of human resource in the institute and motivated the teachers to optimally utilize their skills and professional skills for profession growth and betterment of students.

Focusing on activity based learning he instructed the teachers to organise various cultural and literary activities of national level like Moot Court, Management Fest, Seminar and Conferences in upcoming months. Also he suggested organizing extension lectures by inviting subject experts from industry and academics as well. Prof. Singh suggested management faculty to formulate a platform in collaboration with prospective industries.

Prof. Rajbir Singh specifically focused on starting some weekend and diploma courses in collaboration with industries to increase the employability of the students. He primarily focused on the Skill enhancing, Job oriented professional courses like Cyber Law, Labour Law, Income Tax law, IPR, Company Law, Quality Management, Supply Chain Management and reviving of MBA Executive weekend program from the academic session 2019-20. He also assured that teacher's participation in academic bodies like Board of Studies will be insured to improve the quality of learning and enrichment of syllabus.

Later on our worthy Vice Chancellor addressed the students in college auditorium. While interacting with the students, Prof. Singh highlighted that students are prime stakeholders of any academic institution and it's our prime responsibility to provide the students with all the needed resources for their professional and academic developments. Also he assured that regular faculties will be appointed soon by removing technical issues in ongoing recruitment process. During the interaction with students, students raises several issues like cafeteria, hostels, smart class rooms , DSW facilities, EDP cell organization of annual fest etc. He gave assurance to students that all the matters will be taken on priority for the development and grooming of the institutions.
