The oberoi brand name was also planned to be extended to international quality tissue papers. They also planned to set up a 250 bed, Rs. 40 crore hospital. The Oeroi software division started selling its hotel management packages in the domestic market and planned to enter the international market using an international tie-up.

What linked these projects together was the fact that each of them was to have the expertise of foreign collaboration with an equity stake in joint ventures.

Moreover the hotel business was part of the main blueprint and three-star hotels were to come up at 18 location in India with a joint venture with ACCER of France. The international presence was also to be strengthened through hotels at Budapest, Indonesia and Saudi Arabia.
