While conducting the Viva-Voce Examination through Video Conferencing using electronic means, it may be ensured that it will be open to be attended by members of the Research Advisory Committee, all faculty members of the department, research scholars and other interested experts/researchers, besides the Research Supervisor and Expert(s)/Examine(s), as applicable. It is also impetrative on the part of the University to maintain due record of the same, including the report signed by Expert(s)/Examiner(s) appointed for conducting the same."
