Inspite of seeking time to seek instructions with regard to the common procedure for admission in private technical institutions in accordance with the provisions of the Haryana Private Technical Educational Institution (Regulation of Admission and Fee) Act, 2012, the instructions are still awaited from the State of Haryana.

Evidently, in view of the statutory provisions of the aforesaid Act and the decision of the Supreme Court rendered in the case of Parshvanath Charitable Trust and others Vs All India Council for Technical Education and others (2013) 3 SCC 385 and subsequent decision in the case of Maa Vaishno Devi Mahila Mahavidyalaya Vs State of Uttar Pradesh and others (2013) 2 SCC 617, the State of Haryana has to set up a mechanism for conducting a Common Entrance Test as well as for determining fee that is to be charged by all the institutions imparting technical education as defined in the Act of 2012. It

is informed that the Common Entrance Test for admission to the B Pharma Course is to be conducted in the month of May as per the schedule laid down by the Supreme Court. In the circumstances, the State of Haryana is urgently required to take a decision in this regard and give adequate and due publicity to the same.

Learned Additional Advocate General, Haryana submits that the matter is pending consideration before the authorities of the State and a decision thereon shall be taken at the earliest.

In the backdrop of the facts stated by us in the preceding paragraph, the State of Haryana is directed to take a decision in the matter within two weeks and place the same before this Court immediately thereafter so that the entire process of admission in the technical course(s) can be conducted in accordance with the statutory provisions.
