## ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas, it has been made to appear to me that Novel Coronavirus - known as COVID-19 continues to spreads around the country which is dangerous to human life. As of now, a vaccine has not been formulated for Novel Coronavirus. In light of this fact, prevention appears to be the best cure available so far. Moreover, gatherings of people at Rally, Demonstration, Coaching Centres and religious places to prevent the person to person transmission of the ibid virus which is dangerous to human being which may leads to serious law and order problem in the district. The Haryana Government has also framed the Haryana Epidemic Disease, COVID-19 Regulations 2020 to avoid the spreading of COVID-19 (Coronavirus).

Whereas, it has been made appear to me that there is a need for restriction on gatherings of people at Rally, Demonstration, Coaching Centres and religious places to prevent the person to person transmission of the ibid virus which is dangerous to human life.

Now therefore, I, R.S. Verma, IAS, District Magistrate, Rohtak in exercise of the powers vested in me by virtue of section 144 of the Code of Criminal Procedure, 1973, do hereby prohibit gatherings of people at Rally, Demonstration, Coaching Centres and religious places to prevent the person to person transmission of the ibid virus.

Superintendent of Police, Rohtak and Sub Divisional Magistrates in their respective areas shall be responsible for enforcement of above prohibitory order in its letter and spirit.

This order shall be promulgated in area of Rohtak district by beat of drum, by announcement through the publicity van of Public Relation Department and by affixing of the copies of this order on the notice boards of District Courts/Sub Division/Tehsil Courts/Police

The view of the requirement of the situation which has become emergent, this order spassed exparte and is addressed to the public at large.
