Counseling procedure / instructions to be followed for Institute Level Subject: **Counseling for B. Pharmacy courses for the session 2020-21.**


Kindly refer on the subject noted above.

As already mentioned in brochure of B. Pharmacy for session 2020-21 that after 2nd counseling no online counseling shall be conducted by HSTES and admission shall be made at Institute Level Counseling after merging the sub categories (including female) of a particular reserved category into the main reserved category. In the event of seats remaining vacant /unfilled, if any, same shall be filled up before final cut-off date of admissions without any reservation, firstly on the basis of fresh merit of Qualifying examination in a fair and transparent manner.

A. Important Information/Instructions for Institute Level Counseling(s):

- 1. Instructions issued by Government regarding COVID-19 should be followed.
- 2. The concerned institute to advertise widely for Institute Level Counseling at their own level.
- 3. Institute Level Counseling shall be conducted for the vacant seats as per seat matrix of vacant/ unfilled seats of the Institutions after 2nd online counseling. The category wise vacant seats (after 2nd online counseling) will be available online at www.intrahstes.gov.in on 28.10.2020 for B. Pharmacy.
- 4. Applications along with relevant documents (like Category Certificate, Income Certificate, Haryana Domicile etc.) will be invited through official website / email ID of the institute.
- 5. The schedule of Institute Level Counseling should be displayed on the website of the institute/university for the information of aspiring candidates.
- 6. For admissions in UG Courses Institute Level Counseling shall be conducted on the basis of fresh Inter-se-Merit/ Rank of qualifying examination prepared by the respective concerned university/institute and Inter-se-Merit/ Rank of qualifying examination declared by HSTES (for centralized online counseling) may not be considered.
- 7. The Institute Level Counseling for B. Pharmacy courses shall be done as per the information/ instructions mentioned in concerned B. Pharmacy Prospectus-2020.
- 8. The merit of the concerned course should be hosted online on the website of the institute/university along with the contact no. of the Institute for resolving the queries.

9. After the declaration of merit the respective fees as mentioned for the course in the Prospectus will be collected from the candidates through online / offline as per the facilities available with the Institute (like through Institute account, Google Pay, Paytm



- 10. Before admitting the candidates the institute shall ensure that the previously allotted seat during the centralized/ Institute Level Counseling to the said candidates has been cancelled.
- 11. Before reporting at the newly allotted Institute, candidate shall get his/ her earlier admission, if any, cancelled from previously allotted Institute. If candidate is facing any problem in getting the seat cancellation from previously allotted institute, he/ she may contact HSTES for cancellation of previously allotted seat, if required.
- 12. After checking of all relevant documents as mentioned in the Prospectus, the Institute shall provide the provisional admission slip to the candidate through the email and upload the details of the admitted candidates online on the intra portal of HSTES i.e. www.intrahstes.org.in simultaneously.
- 13. At the time of admission, if it is found that the candidate had not deposited his/ her counseling fees of Rs. 500/- earlier to HSTES, in such a case the candidate shall be informed by the institute to deposit the counseling fees in the account of Institute or deposited online as per the facility available in the Institute. The counseling fee collected by the Institutions be transferred to HSTES account after the last date of admission. 14. Institute Level Counseling shall be conducted on the basis of seat matrix of vacant/ unfilled seats of the institutions and the category wise vacant seats (after 2nd online counseling) will be available online at www.intrahstes.gov.in. 15. The entire exercise for Institute level counseling to be carried out by concerned institute at their own level. However, the detail of each admission and updation to be done on the HSTES portal i.e. www.intrahstes.gov.in for admitted candidates for the courses to B. Pharmacy and shall be completed latest by 30.11.2020 (final cut-off date of admissions) in fair and transparent manner. 16. All the admissions shall be uploaded online on intra portal of HSTES upto 01.12.2020 (11:59 PM) positively. 17. The Chairperson / Director of concerned Department / Institute has to certify that the admissions have been made as per merit in fair and transparent manner, and for any legal / court case if any, he/ she will be responsible.

Procedure to fill Supernumerary seats under Special Categories/ Schemes: C.

1. TFW, EWS and J&K seats in B. Pharmacy course to be filled as per instructions issued by Pharmacy Council of India, New Delhi vide letter dated 30.09.2020:-

The admission / counseling of TFW, EWS & J&K quota seats, shall be done in the Institute/Department of Govt. Universities at their own level through Institute level committee as under:

- Chairperson / Director of the Department / Institute. 1.
- Two senior Professor/Associate Professor/ Assistant Professor of the Institute. 11.

Also, Institute shall update their TFW, EWS & J&K admissions online at Institute level admission on Intra Portal at their respective link. Institute cannot demand the excess fees from candidates as specified by the State Fee Committee, Haryana. TFW Further,

Chairperson/Director of the Department / Institute will ensure that admission made for the supernumerary seats made in transparent and fair manner on the basis of merit. If there is any violation of norms, then Chairperson/Director of the concerned Department / Institute will be responsible for the same.

D. Instructions for online updation of Admissions on www.intrahstes.gov.in:-

a) All admissions by University/Institutes including Institute level admissions are to be updated/ reported online on www.intrahstes.gov.in, as and when the candidate report/ admitted the candidates. No permission of any kind shall be given for admitting students after cut-off dates, if not reported/ updated online on www.intrahstes.gov.in as per Key dates/schedule. The list of online updated candidates for centralized as well as Institute level admissions admitted upto 30.11.2020 will only be forwarded online to the respective University.

- b) No excuse from Institutes regarding non-updation of admissions because of internet not working etc. would be entertained in any case. If institute's internet facility does not work, they should use the facility of nearby institutes or other internet points or cyber café for updation of details of admitted candidates upto last cut-off date. No student should be admitted in any Institution after the last cut-off date i.e. 30.11.2020 under any quota.
- c) Any admission made after the last cut-off date of admission i.e. 30.11.2020 shall be treated as wrong & illegal admission and will not be permitted to update on www.intrahstes.gov.in.

The procedure and Schedule of Institute level Counseling must be given wide public awareness /publicity by the Govt. University themselves.

The admission in institute level Counseling shall be done in fair and transparent manner as per the eligibility and the procedure laid down in the B. Pharmacy Prospectus-2020-21 including above instructions.
