18. Recommendations of the Faculty of Management Sciences in its meeting held on 19.09.2020

To consider the following recommendations of the Faculty of Management Sciences made vide Reso. No. 1 and 2 (any other item) in its meeting held on 19.09.2020 as under:

Reso. No. 1 The scheme of examinations of PhD course of Management Sciences from the session 2020-21 may be prescribed as per (Annexure A/35 pages 266-267, already circulated).

Reso. No. 2 The minimum 5-10 students may be allowed to offer any specialization in group A and Group B in two-year MBA (General) instead of 15 students. Further, resolved that the matter be recommended to Academic Council for approval.

RESOLVED THAT THE RECOMMENDATIONS BE REFERRED BACK TO THE FACULTY OF MANAGEMENT SCIENCES TO REVISIT RESO. NO. 1 AS ABOVE RECOMMENDED BY THE FACULTY OF MANAGEMENT SCIENCES TO PRESCRIBE THE SCHEME OF EXAMINATION IN CONSONANCE WITH THE GENERAL TEMPLATE PRESCRIBED FOR PH.D. COURSE WORK.

FURTHER RESOLVED THAT THE RESO.NO. 2 AS ABOVE RECOMMENDED BY THE FACULTY OF MANAGEMENT SCIENCES BE APPROVED WITH MINIMUM REQUIREMENT OF 10 STUDENTS FOR EACH SPECIALIZATION IN TWO-YEAR MBA (GENERAL).

1. Written examinations in the papers **Research Methodology (20IMSPC1)**, **Quantitative Techniques & Computer Applications (20IMSPC2)**, **Research and Publications Ethics (20IMSPC4)** shall be held at the term end of the course. The question paper in each subject shall be set by an examiner to be appointed by the Chairman, P.G.B.O.S. in Management based on the syllabus prescribed.
2. Internal assessment in each of the papers **Research Methodology (20IMSPC1)**, **Quantitative Techniques & Computer Applications (20IMSPC2)**, **Research and Publications Ethics (20IMSPC4)** shall be awarded by the teacher concerned as prescribed under ordinance by the Maharshi Dayanand University, Rohtak for various P.G. Programmes.
3. In paper **Data Sources for Literature Review (20IMSPC3)**, each scholar will be required to submit 'Unit Report' citing details of work done concerned with each unit (25 marks for each unit). The scholar will be required to study the resources, methodology, features and literature mentioned in syllabus on the allotted topic/area and prepares a comprehensive unit report which will be submitted to the Supervisor on the scheduled date to be decided by the Supervisor.
4. Each student in the Ph.D. course work shall be assigned to a teacher on the basis of specialization/interest area with teacher's consent.
5. The qualifying marks in the each paper of the course shall be 50%.
