False affidavits: EC wants CBDT to probe complaints against MPs/MLAs

New Delhi: The Election Commission has referred false affidavits filed by four MPs/MLAs in the recent Lok Sabha and assembly polls, to the central board of direct taxes (CBDT) for probe. This follows the poll panel's decision in June this year to robustly address the issue of false affidavits in the interest of free, fair and ethical elections, by referring complaints indicating "serious omission on the part of the candidate" to the relevant investigating authorities.

A source confirmed to TOI that

the poll panel had referred to CBDT complaints received against four MPs/MLAs alleging furnishing of false information in their poll affidavits for the Lok Sabha/assembly polls. The source, however, did not reveal the identity of the MPs/MLAs concerned. TOI has learnt that the relevant complaints cite material in support of the claim about the details furnished by the MPs/MLAs in their affidavit not being true; a possible reason why the poll panel found it appropriate to refer them to CBDT.

An update from CBDT is awaited by EC on the follow-up action initiated in the complaints against

four MPs/MLAs. If the allegations are found to be prima facie true, a case may be filed by the CBDT under Section 125A of the RP Act. The section provides for a maximum six-month jail term or fine or both, aspenalty for candidates who failed to give information or furnished false information in poll affidavits.

A candidate, in a poll affidavit, discloses his/her criminal antecedents, assets and liabilities and educational qualifications. EC had in 2018 decided that the assets and liabilities of the candidates, as filed in their affidavits, would be verified by CBDT.

'Govt examining linking Aadhaar to voter ID card'

New Delhi: The government is "examining" a proposal from the Election Commission to link Aadhaar with voter ID cards "to ensure error free electoral rolls", law minister Ravi Shankar Prasad told Parliament in a written response.

"In order to ensure preparation of error free electoral rolls and to prevent duplication of entries, a proposal to amend the Representation of the People Act, to enable de-duplication of electoral data using Aadhaar system has been received from the Election Commission," the minister said, adding that the matter was under examination.

In view of making the existing provisions of the RP Act gender neutral, a proposal to substitute the word 'wife' with the word 'spouse' appearing in sub-section (6) of Section 20 of the RP Act is also under consideration of the government, Prasad said.
