

# Lab reports 106 COVID-19 deaths

## Diagnosis to blame: Health Minister

Tuesday reported 106 COVID-19 deaths, highest in the country since the outbreak, with 1,618. The State reported 106 new cases, 242 positive cases, 242 reported from Jalandhar district.

Health Minister Balbir Singh delayed diagnosis of COVID-19 as the main cause of the high mortality rate. "As many deaths were due to reporting at the health centres suffering severe symptoms," he said. Reports received about resistance to sampling for the virus, Mr. Sidhu even symptomatic with co-morbidities when reporting to the health facilities till the disease became acute.

The cause for maximum deaths being among patients with co-morbid conditions such as diabetes, hypertension and kidney disease, he said, adding that in 50% of the COVID-19 cases in the State have been diabetics. The Health Minister said the delay in reporting at hospitals

and healthcare facilities were on account of false propaganda and fake news being spread by anti-social elements regarding testing and isolation of patients and negative propaganda against health workers.

### 'Take stern action'

Mr. Sidhu asked the Director General of Police to initiate stern action against anti-social elements spreading misinformation.

Meanwhile, Haryana recorded 1,792 new cases on Wednesday, taking the total tally of positive cases to 68,218. The State also reported 15 deaths. The major chunk of new cases, 184 and 152, were reported from Gurugram and Faridabad districts respectively. The active cases are 12,622 and 54,875 patients have so far recovered, said an official statement.

# Farmers to stage protest on Sept. 14

With Parliament's monsoon session slated to start on September 14, ten farmers' outfits have announced to stage protest across Punjab on the same day against the Centre's agriculture ordinances and amendment to the Electricity Act.

Terminating the ordinance promulgated by the Centre against the interest of the farming community, Jagmohan Singh, general secretary of BKU (Dakara), said "We intend to hold big rallies in Amritsar, Phagwara, Barnala, Patiala and Moga on September 14, when the Parliament session begins. The purpose is to convey a strong message to the BJP-led Central government that it should not go ahead with any legislation on the three agriculture ordinances."

# Two more Tripura MLAs test positive

Two more MLAs in Tripura, Kalyani Roy and Subhangshu Das, tested positive on Wednesday. Altogether, seven MLAs have so far contracted the virus.

Meanwhile, Chief Minister Biplab Kumar Debbarma inspected the GBP Hospital here amid reports of deaths of COVID-19 patients due to alleged oxygen insufficiency. He took stock of the situation and held discussions with medical officials.

A portion of the Government Hospital, State's main referral hospital, was made dedicated COVID-19 treatment facility.
