MINUTES THE MEETING OF THE GRIEVANCE REDRESSAL COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 06.12.2021 AT 03.30 P.M. IN THE OFFICE OF DEAN ACADEMIC AFFAIRS TO CONSIDER THE MATTER WITH REGARD TO FILL UP VACANT SEATS OF CERTIFICATE/DIPLOMA PROGRAMS.

The Committee deliberated upon the various issues relating to admissions.

The Committee resolved as under:

1. The Committee considered the requests of S.C. Students and Liaison Officer not to charge the fee/funds from S.C. students at the time of admission whose parents income is not more than 2.5 Lacs for Certificate/Diploma Programs. This provision already exists in the Prospectus of Various Programs applicable to all Colleges/UTDs where even Programs under SFS are being run. Instruction issued from the State Govt. from time to time on this issue shall be followed.

In view of the orders of the Vice-chancellor, the Academic Branch vide letter No. AC-5/F-SC/ST/2021/1805-43 dated 03.02.2021 issued the letter to all the HODs and Director MDU-CPAS Gurugram (Annexure-1). The orders of the Vice-Chancellor were to be placed before the Prospectus preparing Committee during the session 2021-22 but the Academic Branch did not do so. Therefore, the necessary provision regarding not charging of fee/funds

from S.C. Students could not be mentioned in the Prospectus of Certificate/Diploma Programs.

Accordingly the Committee resolved that the above said letter be also be applicable for the session 2021-22 and all HODs and Director MDU-CPAS Gurugram be informed accordingly in the matter. The Committee further resolved that if any S.C. candidate who has deposited the full fee for Certificate/Diploma Programs and requested for refund of fee, that may be refunded as per rules.

 The Committee considered the position of vacant seats as received from the Director UCC regarding Certificate/Diploma Programs for the session 2021-22.

It was resolved unanimously that the following schedule for admission may be notified on the Website of the University and a news item may be got published in the newspapers as applications have been exhausted:-

 The Committee considered the request of the HOD (Psychology) for increasing the seats from 30 to 50 in Diploma in Guidance and Counselling in Psychology Department.

It was resolved that the seats be increased from 30 to 50 for the session 2021-22 only. The admissions will be made from the applicants whose applications have already been received by the Department with in time. The admissions on the increased seats be made by the Department on 13.12.2021 and the fee be deposited by the students on 14.12.2021. The reservation policy already notified shall also be followed by the Department.

 - 2. Diploma in Karma-Kand, (Centre for Maharshi Dayanand & Vedic Studies)
 - 3. Certificate Program in Social Research and Survey, (Deptt. of Sociology)
 - 4. Diploma in Intellectual Property Rights, (IPR Studies)

The Committee resolved that the request of the above HODs be acceded to and also recommended that the provision as mentioned in the Prospectus that if the admissions are less than 10, the Certificate/Diploma programs will not be offered during the session 2021-22 will be applicable to all other Certificate/Diploma Programs.

I am directed to inform that provision mentioned in the prospectus at page 7 for admission to Certificate/Diploma programs offered by UTS and MDU-CPS Gurugram for the session 2020-21 is as under:
