As per the decision of the High Level Committee for Hostels in a meeting held on 30.01.2021 it has been decided that the Girls Hostel(s) may be opened (1) For Ph.D Scholars who were residents of hostels in the previous session in the subjects of Science & Technology and (2) For Students of other programs running in UTDs (For Lab/Practical purpose only), with the following conditions:

I. For Ph.D Scholars (only Science & Technology)

- a. The scholars should submit RT-PCR (COVID -19) negative test report conducted within 72 hours before the admission to the Hostels.
- b. If a resident after taking admission stays away from the hostel for **more than three days,** She will have to submit the negative test report again, conducted within 72 hours before re-entering the Hostel.
- c. The Hostel admission form should be forwarded by the concerned Supervisor & the Head/Director of the department/Centre alongwith "No Objection" Certificate from the parents.
- d. The interested Ph.D scholars are required to submit requisite undertakings and an additional proforma in the format attached with the application form (Annexure –A) duly countersigned by respective Supervisor/Guide and Head of the Department/Director for their admission in the University Hostel.
- e. The accommodation in the Hostels will be allowed upto June,2021.
- f. Students expelled during the past from M.D.U. Hostels are not eligible to apply.

II - For Students of other programs running in UTDs (For Lab/Practical purpose only)

- a. The students are required to submit RT-PCR (COVID-19) negative test report conducted within 72 hours before the admission to the Hostels.
- b. If the resident after taking admission stays away from the hostel for **more than three days**, She will have to submit the negative test report again, conducted within 72 hours before re-entering the Hostel.
- c. The Hostel admission form should be forwarded by the concerned Head/Director of the Department/Centre alongwith "No Objection" Certificate from the parents.
- d. The accommodation in the Hostels will be given w.e.f. 01.02.2021 during the period of Lab/Practical Work, for old residents and for the above mentioned specific purpose only.
- e. The residents will have to pay stay charges for one month if they stay for less than one & half month and for two months if they stay for more than one and half months. In no case, the hostels will be provided for more than two months.
- f. The mess charges will be separately charged.
- g. Students expelled during the past from M.D.U. Hostels are not eligible to apply.
