Existing Eligibility

Proposed Eligibility

One supernumerary seat in each Department for the Corporate Professionals working atleast at Deputy General Manager (DGM)/General Manager Level (or equivalent thereof) or Deputy Director/Director (or equivalent thereof) for minimum ten years at Corporate level with the condition that the Company's turnover should be at least 300 erores per annum.

One supernumerary seat in each Department for the Corporate Professionals and having 10 years minimum experience with the condition that the Company's turnover should be at least 300 crores per annum.
