Respected Sir,

I (Bhagat Singh) Dept. of Physical Education want to draw your kind attention on the following facts regarding issue of seniority of Teachers of the department of Physical Education.

1. Dr. R.P.Garg and Dr. Kultaj Singh were appointed in the PGRC Rewari and Erstwhile University college in 1991 respectively. Dr. R.P.Garg had applied for the post of lecturer in the Dept of Physical-Education in 1995 but was not found eligible and hence not called for interview whereas I was selected for the post. Whereas Dr. Kultaj singh was transferred from the university college after its closure/takeover by the govt.

2. I was selected by duly constituted selection committee exclusively for the post of lecturer in the dept. of Physical-Education in 1995 and later on promoted on the post of Reader and Professor. It is pertinent to mention here that both of them were not sentitled to promotion on the post of Reader being the different cadres.

- 3. There is no statutory policy for transferring faculty members from the university college or regional centre to the university teaching Dept. As a one-time exception teacher of University college were transferred to UTD. It was resolved by the EC vide resol. 27 dated 5.08.12 that Those who had never been reader (college Teachers) will not be senior than who have been reader in the University Teaching Dept. It was applicable on all the teachers of university college.
- 4. After considering the recommendations of the committee, EC vide resolution No.46 dated 13-09-2017, resolved that the recommendation of the committee be approved and the state govt. be requested to allow merger of Dr. R.P.Garg in the university as required under section 9 F of the university act, after that chancellor assent shall be obtained. As the consent of the chancellor was not taken by the office therefore the

merger process has been incomplete and it is in violation of above said resolution of the Executive council.

- 5. Dr. Kultaj Singh acquired his M.Phil and Ph.D. degree by fraudulent means from Vinayaka Mission University and CMJ Meghalaya respectively. The verification conducted by the University for his Ph.D. degree speaks volume about fraud. Even The EC in its meeting held on 3Augst 2015 for taking the cognisance of his reply to his explanation resolved that Mr. Kultaj Singh be heard in next EC meeting before taking the final decision in that. But even after this in the next meeting off the EC Dr. Kultaj Singh not appeared before the committee and EC resolved that EC will take the exparty decision in absence of his appearance and the EC displeasure be conveyed to him. T hereafter university not brought any agenda in the EC which is again the violation of EC decision.
- 6. The EC in a recent meeting held in 2022 resolved the seniority, on the recommendation of an expert committee constituted by university as follows:
 - 1. Dr. Bhagat Singh
 - 2. Dr Kultaj Singh
 - 3. Dr. R.P.Garg.

Now in the ensuing EC meeting dated 6-04-2022 another agenda item has been brought to undo the decision of last EC meeting in the process violating all the decisions of the EC. The whole issue may be reconsidered in the light of above stated facts after deferring the agenda item.
