(iii) In B.A.LL.B. (Hons.)/B.B.A.LL.B. (Hons.) 5 year course, the exit is not allowed by the Bar Council of India. Hence, the degree of B.A.LL.B. (Hons.)/B.B.A.LL.B. (Hons.) only shall be awarded after the completion of the 5 year course.	(iii) NO CHANGE
	(iv) A student who has passed B.A./B.Sc./B.Com./BBA in Hons. under common Ordinance for 5-year Integrated Programs, are allowed to appear in additional subject(s) of B.A. (Pass Course) except in the subject(s) which he/she has already passed, subject to maximum duration as specified in Clause-13 of the Ordinance i.e. 6 years in case of exit after first module and 8 years in case of exit after second module.
