Set Physical Counselling on 17:10:2022 to fill up the Increased/vacant/left over seats for admissions to PG Programs in the UTDs in the session 2022-23.

Sir/Madam.

In continuation to this office letter No. AC-VI/22/F-86/20286-20365 dated 06.10.2022, I am directed to inform you that keeping in view the demands regarding increase of seats in different Programms being run in UTDs and MDU-CPAS, Gurugram, the following recommendations have been made by the Grievance Redressal Committee in its meeting held on 11.10.2022:

- i. 10% increase in number of seats of the sanctioned intake in all PG Programms involving lab/practical work (except those pertaining to regulatory bodies) being run in UTDs and MDU-CPAS.Gurugram.
- ii. 20% increase in number of seats of the sanctioned intake in all PG Programs devoid of lab/practical work being run in UTDs and MDU-CPAS, Gurugram.

The Vice-Chancellor has approved the above recommendations of the Grievance Redressal Committee in anticipation of approval of Admission Committee and passed orders to conduct physical counselling on 17.10.2022 by the University Teaching Departments and MDU-CPAS (running two Year PG Programms including LL.B. 3 Year Programm)(except the Programs which comes under the purview of regulatory bodies i.e. AICTE, NCTE, PCI, BCI) to fill up the increased/vacant/left over seats (including Supernumerary seats) for admission to 1<sup>st</sup> semester in PG Programs, by advertising the same on the University website, in the session 2022-23 in the following manner as per instructions mentioned at point no. 16 of page number 9 of the PG Prospectus 2022-23 which provides as under:

If the seats remained vacant after 3<sup>rd</sup> Counselling in UTDs/affiliated Degree Colleges, the UTDs/affiliated Degree Colleges may fill up the vacant seats by adopting the following procedure at their own level:

- (iv) Firstly, the vacant seats, if any, will be filled up by the candidates who have appeared in the Entrance Test.
- (v) Secondly the vacant seats, if any, after (i) above, will be filled up by the candidates who have registered for admission but did not appear in the entrance test.
- (vi) Thirdly, the vacant seats, if any, after (i) and (ii) above, will be filled up on the basis of Academic Merit by inviting tresh applications.

The candidates will be required to mark their attendance in the concerned Department/Institute on 17.10.2022 from 09.00 AM to 11.00 AM and the merit list of such candidates be displayed on the notice board/website upto 12.00 Noon. Candidates admitted against such seats shall deposit the full admission fee upto 18.10.2022. The Reservation guidelines as mentioned in the Prospectus for PG Programs along with Roaster Register being maintained by the Departments/Institute be followed.
