## **Academic Profile**

The Convener of the Collaborative Conference of the proposed topic entitled 'Public Policy and Governance in India: Innovations and Experiences" is presently working as the Professor and Head, Department of Public Administration, M. D. University, Rohtak. He was graduated in Medical stream from the then Pt. Neki Ram University College, Rohtak which is currently known as Pt. Neki Ram Government College since 1987. He completed his Post Graduation in Public Administration from the Department of Political Science, M.D. University Rohtak in 1990. He passed his M. Phil Degree from the same Department in the year 1991 and qualified the National Eligibility Test (NET) in Public Administration in the year 1993. He completed his Ph. D. degree from the Department of Public Administration in the year 1998. He joined the Department of Public Administration as a Faculty in the year 1995. He has also contributed in the development of Study material for EPG Pathshala.
