1. The Committee considered the requests made by the candidates applied under MBA (Executive) Program regarding change in admission from MBA (Executive) Program to MBA Program.

Resolved that the admission to MBA Program will be given first to the candidates who appeared in Entrance Examination. Thereafter, if seats still remain vacant, opportunity may be provided to the candidates in 4th Counselling on the basis of Academic Merit in following orders:-

i) Candidates who have applied for MBA Program and did not appear in the entrance test.

ii) Candidates who have applied for MBA Executive Program.

2. The Committee considered the representation received from Jai Bheem Welfare Trust , SC Category regarding proper bifurcation of SC & DSC candidates in UG/PG admission 2024-25 on the line/patter of KUK and CCSHAU, Hisar

The Committee considered the representation as well as submission by the office and observed that University provides reservation strictly as per State Govt. norms.

3. The Committee considered the request of Ms. Chhaya for conversion of vacant seats of Reserved Category to General Category and grant admission to Ph.D Program (UIET-CSE) 2023-24 as in accordance with Page-29, Clause-11 of Ph.D Prospectus session 2023-24.

Resolved the candidate may be considered for admission to Ph.D Program 2023-24 session along with permission to pursue Ph.D Coursework in 2024-25 session. *subject to the condition that she will*

4. The Committee considered the request made by Ms. Neha student of BA LL.B. 2nd Year regarding fee concession due to financial program.

Resolved that the Director, MDU-CPAS, Gurugram be requested to verify the genuineness of the application along-with supporting documents.

9. The Committee considered the request of Ms. Nancy Phougat regarding Missing of Physical Test for admission to B.P.Ed Course which was held on 17.07.2024


Resolved that the request of the candidate may not be acceded to.


10. The Committee considered the request of Mr. Nitish regarding Permission for admission to B.P.Ed. against Physical Handicapped quota.
