## Submission Guidelines

1. The research papers in the form of soft copy on the e-mail- [mdulj@mdurohtak.ac.in](mailto:mdulj@mdurohtak.ac.in) based on original research are invited by **August 31, 2024** (Last date of submission), in the format of 12 point text single font Times New Roman in MS word package of English Language, Line Spacing 1.5.
2. The contributor must certify that paper is his/ her original work and has not been published wholly or partly in any other journal nor has been submitted to any other journal. The paper should not be plagiarized (same will be checked) and free from grammatical, spelling and other errors. The copy right form is enclosed herewith.
3. The research paper must be accompanied with the abstract and keywords. Abstract shall be not more than 300 words, keywords also not more than eight (8) and all the footnotes should be numbered serially and be placed on the bottom of the page, starting with the designation and address of the author.
4. The pattern of footnotes/references must be strictly followed as prescribe in ILI format.
5. The content of the research paper/ article should not be less than 2500 words and should not be more than 5000 words (including footnotes and the abstract).
6. Review Process: All papers will be reviewed anonymously by the Editorial Board. Authors will be notified within four weeks about the status of their papers. Request for expedited review will not be entertained.
7. All authors will be provided only one complimentary copy of the issue in which their paper is published.
8. Co-authorship is allowed subject to a maximum of two. Every co-author need to be subscribe the Journal for obtain his/her copy.
9. All decisions of the editorial board shall be final and no further communication shall be entertained in this regard.
10. Full name, address, contact no., email id of the author along with designation must be given.
11. The editor- in -chief reserve its right to reject any of the article without assigning any reason, which is in the opinion of the editor-in chief not fit for publication and for that no reasons will be assigned.
