The Committee considered the various issues/ Grievances / requests received from the candidates relating to admission to 4-Year UG/5-Year Integrated and PG Programs 2024-25 and after detailed deliberations, the Committee resolved as under:-

1. Considered the Follow up Action of the meeting of the Standing Grievance Redressal Committee held on 23.07.2024.

Noted the Follow up Action taken by the Academic Branch on the Minutes of the meeting of the Standing Grievance Redressal Committee HELD ON 23.07.2024.

2. Considered the request/complaint of Mr. Sagar for admission against Sports Quota in B.A. (History) 4-Year Program

Resolved that in the light of the Resolution of the Admission Committee of the Dept. of History and Archaeology dated 17.07.2024 under Point No.1, the request of Mr. Sagar may not acceded to as the candidate is not eligible.

3. Considered the request/complaint of Ms. Rupa Nandal against the admission of Ms. Kajal in M.P.Ed. Program for the session 2024-25.

Resolved that no further action is required as the submission of HOD Physical Education regarding admission of Mr. Kajal is in order as per provision contained in the Prospectus for PG Programs 2024-25.

4. Considered the complaint of Mr. Kapil, Mr. Rohit Ahlawat and Mr. Rupa Nandal against the admission of Ms. Nikita Mann, Mr. Tushar, Mr. Rohit and Mr. Ankush Dalal in B.P.Ed. Program.

Resolved that:-

- i) Director (Sports) may be asked to arrange to get all relevant details from the organizers of the event about the participation of the team including the different slots/matches in the said event to the MDU Team within next 07 (seven days) i.e. upto 31.08.2024.
- ii) Director (Sports) may be asked to submit a detailed report including itinerary related to the travel of each participant of MDU Team alongwith Railway Tickets used for the said journey i.e. from Rohtak to Nasik and back. Further, Director (Sports) should submit all the necessary documentation on the basis of which the certificates were issued to this effect.

5. Considered the request of Mr. Amit for admission to M.P.Ed. Program.

As per submission of Director, Sports and comments of Convener, Admission Committee that "as per HBI, Fast 5 Netball National is not in the list of AIU Games. Hence, it will not be considered for admission to M.P.Ed. Course", accordingly, the request of Mr. Amit cannot be acceded to.

6. Considered the request of Ms. Shivani Jaglan for admission in LL.M. Course against Sports Quota seats

Resolved that keeping in view of the opinion expressed by Director, Sports and HOD (Physical Education), the request of Ms. Shivani Jaglan cannot be acceded to, being over age.

7. Considered the request of Mr. Aryan Ahlawat for admission in LL.M Program against supernumerary seats (Sports Quota).

Resolved that being change of category, the request of Mr. Aryan Ahlawat cannot be acceded to at this point of time.

8. Considered the request of Mr. Jatin, for admission on the supernumerary seat (Cultural Activities) in M.A. (Political Science).

As informed by the HOD (Political Science), there is no other applicant in the category of Cultural Activities under supernumerary seat and that the candidate has obtained first position in Haryanavi Poetry category only upto the level of Inter Zonal Youth Festival, the house resolved that the request of the candidate may be acceded to as a Special Case in absence of further avenues of higher level in the concerned Competition/Event.

9. Considered the matter of Ms. Ashita for depositing of admission fee on the portal for 4-Year UG Program in Economics but could not receive her admission fee in University Account due to technical problem. The matter discussed in the last meeting held on 23.07.2024 and the comments of the Finance Officer has been

Resolved that the request of the candidate may be considered for admission and HoD Economics may process the case for admission in view of some vacant seats lying in 4-Year UG Programs as informed by HoD, Economics.

10. Considered the request of Registrar, World Institute of Technology, Sohna, Gurugram for condoning the delay regarding submission of Continuation Return (CR) and promote to B.Tech 5th Sem. in case of Mr. Mohmmad Junaid

Resolved that the penalty of Rs.25000/- for gross negligence by the College + Rs.10000/- towards late fee may be imposed for non-submission of examination form/fee by the World Institute of Technology, Sohna. The College may also be issued strict warning not to repeat such lapse(s) in future.

11. Considered the Memorandum of Saheed Bhagat Singh Chhatra Sangathan for admission against vacant seats of Sports Quota in the University Teaching Departments/ Institutes/Centres.

Resolved that admission against Sports Quota under supernumerary seats may be ensured as per rules prescribed in the Prospectus for PG Programs 2024-25. It is further resolved that a Committee may be constituted to look into the existing provisions under various Sports Category seats and recommend necessary changes, if any, required to be incorporated in the Prospectus for 2025-26.
