Copy of extract of Reso. No. 18(5) of Executive Council's meeting held on 29.06.2024

**Consideration of the recommendations of the Committee constituted by the Vice-Chancellor for entering into MoU between ICAR – National Research Centre on Equines, Hisar and Maharshi Dayanand University, Rohtak for promotion of inter-institutional research collaboration and students' Training and Research (Annexure A/7 pages 83-90, already circulated).**

Dr. Manjeet Kaur, Associate Professor, Bio-Technology (UIET), M.D. University, Rohtak forwarded a proposal vide letter no. UIET/2155 dated 15.09.2023 regarding entering into long-term collaboration for promotion of inter-institutional research, staff and students' training and research in cutting edge areas with ICAR – National Research Centre on Equines, Hisar and Maharshi Dayanand University, Rohtak.

Accordingly, the matter was referred to the Standing Committee, as constituted by the Vice-Chancellor. The committee in its meeting dated 18.10.2023 and 02.11.2023 considered the matter and after deliberating at length, it was resolved that the MoU with ICAR – National Research Centre on Equines, Hisar as proposed by the UIET shall be helpful for the Research Scholars belonging to the field of Life Science. The recommendations of the Standing Committee was approved by the Vice-Chancellor and MoU was signed on 12.04.2024.

The Academic Council vide Reso. No. 9 in its meeting held on 27.06.2024 considered the above and passed the following resolution:
