Copy of extract of **Reso. No. 18(2)** of Executive Council's meeting held on **29.06.2024**

Ratification of the action taken by the Vice-Chancellor, in anticipation of the approval of the Academic Council, in approving the amendment in Clause-4 of the Ordinance 'Academical Costume' appearing in University Calendar Volume-II (Part-B) as under:

The Dress Code/new costume of the Teachers/Members of the Executive Council/ Court/Academic Council/Students/Staff on duty for convocation was approved by the Executive Council vide Resolution No. 2 in its meeting held on 13.04.2017 (**Annexure A/3 pages 77-79, already circulated**).

However, there was no mention of any specified colour code of sash for the Vice-Chancellor, Dean Academic Affairs, Registrar and Controller of Examinations in the above Resolution. Thus, it was proposed that the sash colour prescribed for the official guests may also be allowed to be made applicable for the Vice-Chancellor, Dean Academic Affairs, Registrar and Controller of Examinations.

Further, in the dress code, there was no mention of Blazer/Coat/Pullover/Sweater/Jersey despite the fact that the convocation was being conducted in winters. Therefore, use of white/off white colour for Blazer/Coat/Pullover/Sweater/Jersey without any border was also proposed.

The whole matter was placed before the Vice-Chancellor, who approved the same in anticipation of the approval of Academic Council and ordered to refer the same to the Academic Council for ratification.

The Academic Council vide Reso. No. 6 in its meeting held on 27.06.2024 considered the above and passed the following resolution:

RESOLVED THAT THE ACTION TAKEN BY THE VICE-CHANCELLOR AS ABOVE IS RATIFIED AND RECOMMENDED TO THE EXECUTIVE COUNCIL FOR CONSIDERATION.

The Executive Council considered the recommendations of the Academic Council; and

RESOLVED THAT THE RECOMMENDATIONS OF THE ACADEMIC COUNCIL AS ABOVE BE APPROVED.
