The special round of counselling schedule in the B.P.Ed Programs against five (5) vacant seats where the candidates who have already applied and/or not appeared in the PET / Entrance examinations, shall be as under:-

At the time of counselling, the preference for the admission will be given in the following order :-

- Firstly, the admissions shall be offered to those candidates who have appeared in PET & qualified the same and also appeared in the Entrance Test.
- Secondly, the admission shall be offered to those applicants who have not appeared in PET or did not qualify PET earlier but later on qualified PET on 09.09.2024 and the candidates who had already appeared for PET & qualified the same, both put in the same list and such candidates be considered for admission on the basis of academic merit.

The last date for submission of documents related to qualifying examinations in case of newly admitted students in the above Programs is 30.09.2024.

If more seats fall vacant till the date of counselling, the admissions will be considered against those seats also on the concerned date(s) of counselling.
