MEMORANDUM OF UNDERSTANDING BETWEEN MAHARSHI DAYANAND UNIVERSITY ROHTAK E AND M/S. JAI BABA SHEVAGER ENTERPRISES, SHOP NO. 12, OPP. RANAKPURA, ROHTAK, HARYANA - 124001 This MoU is signed on 03-07 - 2024 ( ) in between Registrar, M.D. University Rohtak (herein referred to as MDU) having its headquarters at Rohtak which expression shall include its authorized representative (s) / assignee(s)/ successor(s) of the one E part and M/s. Jai Baba Shevager Enterprises, Shop No. 12, opp. Ranakpura, Rohtak, Haryana -124001 having its office at Rohtak (hereinafter called the agency) expression shall include its authorized representative(s)/ assignee(s)/ successor(s) of the other part in pursuance of the M/s. Jai Baba Shevager Enterprises, quotation in response to the E-tender no. 2024\_HRY\_369467\_1 dated  $\S$  15/03/2024 and negotiation between the two parties during the tender committee meeting held on 13/06/2024 for award of contract of Maintenance, Running and operation of 50 Mtr and 25 Mtr length of Swimming Pools (excluding diving pool) including housekeeping, electrical and public ghealth maintenance services of the Swimming Pool in MDU, Rohtak. a Now in pursuance of the said decision to execute the above said contract the two parties to this MoU with a common intention of being legally bound mutually agree to abide by the following terms gand conditions for the aforesald purpose. §1. a). That the Agency pay advance rent to the University as under:i. and will not be adjusted against monthly rent of swimming pool or against any other payment due to the university. due to the university during the tenure of the contract. In case, the time of completion is enlarged, the validity of the enlarged, the validity of the guarantee shall be correspondingly extended. It carries no interest and is refunded to the and is refunded to the contractor after the date specified in the contract.

- 3. Monthly advance rent will be paid by the agency in favour of Secretary MDUSC and maintained during subsection. during subsequent months.
- 4. The service provider will be responsible for maintenance, running and operation of University Swimming pools for swimmers and learners (Diving Pool is excluded).
- 5. That the Agency will keep swimming pool area including the compound and immediate surrounding neat and clean by cleaning pool water after proper water treatment at least once a week or as required from time to time.
- 6. The agency shall also be responsible for housekeeping services of the entire Swimming Pool Building such as daily cleaning and sweeping of all floors, cleaning of bathrooms/toilets, cleaning of change rooms and maintenance of public health services in bath rooms and maintenance of electrical fittings in the buildings. Maintenance of pumps, motors, valves, filter medias, starters etc./for running and operation of Swimming Pool shall be the responsibility of the agency. However, replacement of pump, motors, valves will be done by the University, if required.
- 7. That the Agency shall appoint only trained, experience and qualified staff especially lifeguards and Swimming Coach separately for ladies and gents and staff will remain present during the time of swimming and will follow all relevant rules/ laws in this respect and university shall not be responsible for any kind of liability arising out of it.
- 8. That the Agency shall provide life jackets and all other required life saving equipments to the pool users and shall not allow the non-swimmers to enter in the pool without life jackets.
- 9. Pools will be made available for use by MDU students/student of the College or Institutes affiliated with MDU/staff and families, outstanding sports persons (under training by MDU Coach) and general public for whom I-Cards will be issued by the agency and further attestation by Director Sports. The fees for application form along with I-Cards for MDU students / student of the College or Institutes affiliated with MDU, MDU staff and their wards will be Rs. 100/-.
- 10. That the Agency shall provide swimming services to the members and duly authorized non members on the rates fixed by the Director Sports.

For outsiders, fees will be decided by the agency itself.

However, any exemption/relaxation of fees will be permitted by Vice-Chancellor of the University to a limited extent.

- 42. The agency/firms/bidder will provide the facilities of the University Swimming Pool during games/ tournaments to be organised as per University Sports Calendar by the Directorate of Sports time to time, free of charges.
- 43. The agency/firms/bidder will provide facilities of the University Swimming Pool to the University trainees participating for Swimming Meet on behalf of the University under the Swimming Coach of the University during the whole session, free of charges.
- 44. The concerned firm/agency will be entirely responsible for any mishap occurred due to mechanical /electrical faults in the instruments/machines already installed/available in the University Swimming Pool.
- 45. Electricity and water for operational of the University swimming pool will be provided by the university free of cost. However, for the front building of swimming pool comprising office. VIP rooms, changing room, etc the electricity charges will be paid by the agency on prevailing rate on the basis of separate electricity meter installed by the university.
- 46. The University Swimming Coach will impart training to the University employees, their wards, outstanding sports persons and students. However agency will ensure provision of Life Savers/ Coaches as faid down and they will be fully responsible for the safety and security of the users even when University Coach is imparting training.
- 47. Swimming pool area shall be strictly kept non-smoking and non-alcoholic zone by the agency. For any lapse whatsoever the agency shall be liable for penal action as approved by the Vice-
- 48. No un-authorized/illegal activities will be allowed in or around the Swimming Pool Complex and the contractor will follow all the instructions/orders of the District Administration & University
