It is to inform you that considering the request of scholars/students, the Vice-Chancellor has passed orders to extend the last date for applying for Ph.D. Registration and deposit of application fee upto 15.11.2025.

You are, therefore, requested to ensure that the above information may be circulated among all the candidates of your Departments well in time.

Further, the following points should also be confirmed while applying for Ph.D. Registration:-

1. Diary No. may be written on all the applications for Ph.D. Registration along with date of receipt in the Department.
2. The whole process of holding the meeting of the RAC, DRC and PGBOS/BOS shall normally be completed within 3 months from the last date of receipt of applications for Ph.D. Registration in each cycle. In case the Department is not able to meet the deadline, the HoD's/Director's would seek condone the delay at own your level with valid reasons for not completing the Registration process within the stipulated time from Vice-Chancellor."
3. The self attested photocopies of all the certificates from Matric to Ph.D. Course Work, admission form to Ph. D. Programme with fee receipt of admission, minutes of DC, RAC, DRC & PGBOS/BOS, duly signed by all the members and synopsis (signed by the candidate and Supervisor) may be attached along with application form Ph. D. Registration.
