Sub: - Revised norms regarding the entry and superannuation age for various Teaching and Non-Teaching staff applicable in SFS Colleges/ Institutes (Engineering, Management, Architecture, Law, Degree and Education) as well as SFS programs being run at Govt. Aided Private Degree & Education College.

Sir/Madam,

I have been directed to inform you that the Academic Council vide Reso. No.58 in its meeting held on 02.09.2025 considered the revised norms regarding the entry and superannuation age for various Teaching and Non-Teaching staff applicable in SFS Colleges/ Institutes (Engineering, Management, Architecture, Law, Degree and Education) as well as SFS programs being run at Govt. Aided Private Degree & Education College and resolved as under:-

- Minimum age for the entry in the service shall be 18 years.
- Maximum age limit for appointment of Director/Principal, Teaching Staff in SFS Colleges/Institutes (Engineering, Management, Architecture, Law, Degree and Education) as well as SFS programs being run at Govt. Aided Private Degree & Education Colleges shall be 68 years. However, the age of Superinannuation shall be 70 years.
- Maximum age limit for appointment Non-Teaching staff in SFS Colleges/Institutes (Engineering, Management, Architecture, Law, Degree and Education) as well as SFS programs being run at Govt. Aided Private Degree & Education Colleges shall be 63 years. However, the age of Superinannuation shall be 65 years.

The above recommendations of the Acedemic Council have also been considered by the Executive Council and approved the same vide Reso. No.10 (29) in its meeting held on 29.09.2025.
