I have been directed to inform you that the Practical examinations of subject cited programs are to be conducted as per schedule given as under:

While conducting the Practical Examinations as per above schedule, the Director/Heads concerned will be required to ensure that:

- The eligible External Examiners for conduct of Practical Examinations may be invited from the places having distance not more than 100 kms (eacg way);
- 2. The Practical Examinations shall be conducted judiciously as per above schedule;
- The uploading of Practical Awards is mandatory. Therefore, after conducting the Practical Examinations the Instt/Deptt. concerned must upload the marks awarded by the Examiner on the University portal latest by 12.10.2025;
- 4. In case due to any technical reason, if any awards could not be uploaded on the portal, the same may be sent to the Conduct Branch with separate covering letter mentioning therein the specific technical reason for not uploading the awards. Such awards must reach the Conduct Branch with justification latest by last date of uploading of awards i.e 12.10.2025;
- After uploading the Awards, the Instt./Deptt. shall also submit External Awards as well as
  Forwarding Memo of Practical Awards List (in original) duly properly filled in all respects to the
  Asstt. Registrar(Conduct), M.D. University, Rohtak, within further fifteen days after uploading the
  External Practical Award i.e. latest by 21.10.2025;
- 6. While submitting TA/DA Bills, the Practical Examiner must be required to clearly mention their full name, designation with Grade Pay, Name of College, Contact no., Name of Course with Semester and Session and the same may be submitted to the Accounts Branch of the University directly;
- 7. In case any Instt./Department does not upload the external awards on the University Portal latest by 12.10.2025, the late fee will be levied w.e.f. 13.10.2025 as per University Rules, irrespective of the submission of original external awards in time;

8. The Director, Centre for Disability Studies is also requested to ensure to supply the required details as mentioned below for the remuneration of external Practical examiners. It is mandatory to supply Beneficiary ID of Practical examiner for their remuneration:
