

The College concerned shall also submit Original forwarding memo and List of Practical Awards complete in all respects i.e. - having details of total Present and absent students, full signature and complete address of the Practical External Examiners with contact No. along with soft copy of the videography done, to the DR (Conduct), M.D. University, Rohtak, within further seven days after uploading the External Practical Award latest by **29.04.2026**, failing which late fee will be charged from the College concerned as per University Rules.

Important Notes:-

1. While submitting TA/DA Bills, the Practical Examiners must be required to clearly mention their full name, designation with Grade Pay, Name of College, Name of Course with Semester and Session and same may be submitted to the Accounts Branch of the University directly.
2. IT IS MANDATORY FOR THE COLLEGES TO CONDUCT VIDEOGRAPHY AND THAT TOO AT THEIR OWN LEVEL (EXPENDITURE FOR THE SAME WILL BE BORNE BY THE CONCERNED COLLEGE/INSTITUTE ITSELF).


