NOTIFICATION

On the recommendations of the Committee constituted by the Vice-Chancellor made in its Meetings held on 05.01.2026, 12.01.2026, 20.01.2026 & 21.01.2026 regarding SETC (State Eligibility Test in Computer Appreciation & Applications) duly approved by the Executive Council vide Resolution No. 45 in its Meeting held on 23.03.2026 and in supersession of earlier Notification issued vide Endst. No. EN-5/2025/SETC/12353-473 dated 24.10.2025, the following conditions have been adopted by the University:-

- (a) The condition for passing of SETC be applicable on or after 29.09.2025 as the SETC adopted by the University vide Executive Council Resolution No. 20 dated 29.09.2025.
- (b) That all those persons who have been appointed, promoted and absorbed to the post of Clerk/Clerk-cum-JDEO/Steno-Typist/Jr. Store Keeper/Store Keeper on or after 29.09.2025 shall have to pass both the components of SETC i.e Part I (Basic Computer Knowledge Test) and Part II (Typing Test). However, the Physically disabled candidates i.e amputation of hand (Left & Right), Amputation of upper limbs, Paralysis of Radial Nerve (Redial Nerve Palsy) either upper limbs, Declination Degenerative disorder effecting the nervous system which may cause paralysis and atrophy of the hand and its muscles and Visually Handicapped candidates, as defined in the Government instructions dated 07.11.2013 against point No. 9(v), may be exempted from qualifying the SETC Test.
- (c) Since the Seniority List for Clerk/Clerk-cum-JDEO/Junior Store Keeper/Store Keeper, etc., is prepared jointly, the condition of passing the SETC test will also apply to those Junior Store Keepers/Store Keepers, etc., who were/are initially appointed/recruited/promoted to this post on or after 29.09.2025.
