I am directed to inform you that the matter on the subject cited above has been considered by the Standing Grievance Redressal Committee in its meeting held on 01.04.2026, duly approved by the Hon'ble Vice-Chancellor which is reproduced as under:-

“CONSIDERED THE MATTER WITH REGARD TO ADMISSION TO PH.D. PROGRAM FOR THE SESSION 2025-26 IN LIGHT OF THE JUDGEMENT CWP NO. 36962-2025 (O&M) DATED 17.03.2026.

THE COMMITTEE WAS APRISED THAT THE UNIVERSITY VIDE ITS LETTER DATED 10.12.2025 PUT ON HOLD THE PREPARATION OF MERIT LIST/COUNSELLING PROCESS ETC. FOR ADMISSION TO PH.D. PROGRAM FOR THE SESSION 2025-26. NOW, IN VIEW OF THE HON'BLE PUNJAB AND HIGH COURT, CHANDIGARH JUDGEMENT IN CWP 36962-2025 (O&M) DATED 17.03.2026, THE COMMITTEE MADE FOLLOWING RECOMMENDATIONS:

- a) *THE HEADS/DIRECTORS OF THE UTDS BE REQUESTED TO CONTINUE THE PROCESS FOR ADMISSION TO PH.D. PROGRAM ON THE VACANT SEATS AS PER THE UNIVERSITY INSTRUCTIONS MENTIONED IN THE PROSPECTUS/ORDINANCE AND AS CIRCULATED FROM TIME TO TIME BY CONSIDERING THE UGC NET CATEGORY -I/II/III PASSED APPLICANTS AS PER UGC REGULATIONS DATED 27.03.2024.*
- HOWEVER, THE VALIDITY OF ONE YEAR, AS PER UGC REGULATIONS, BE APPLICABLE BY CONSIDERING THE CUT OFF DATE AS LAST DATE FOR APPLYING ONLINE FOR ADMISSION TO PH.D. PROGRAM FOR THE SESSION.*
- b) *THE COUNSELLING ON SUCH VACANT SEATS, SUBMISSION OF FEE AND ADMISSION TO PH.D. PROGRAM BE MADE AS PER FOLLOWING SCHEDULE:-*
