While conducting the Practical Examinations as per above schedule, the Director/Heads/ Principals concerned will be required to ensure that:

- In pursuance of the E.C Resolution No. 17(42) of the meeting held on 30.01.2025, the Practical Examinations for all the UG/PG NEP 2020 Programs will be conducted internally and wherever there is non-availability of Internal Examiners, External Examiners may be appointed with the permission of the Vice-Chancellor.
- In respect of other Practical Examinations, the appointment of Practical Examiners will be made only out of the approved panel(s) of Practical Examiners of subject concerned, which is available on the University website www.mdu.ac.in. and may be downloaded there from;
- In case of UTD (s), the External Examiners for conduct of Practical Examinations may be invited from the places having distance not more than 200 kms (each way); whereas, the External Examiners for conduct of Practical Examinations in affiliated colleges may be invited from the places having distance not more than 100 kms (each way). However, in any case any affiliated College/Instt feels difficulty to invite the examiner(s) for some specialization from within a radius of 100 Kms, in such cases prior permission of the Controller of Examinations may be taken giving full justification.
- The Practical Examinations shall be conducted judiciously as per above schedule;
- The uploading of Practical Awards is mandatory. Therefore, after conducting the Practical Examinations the Instt./Deptt./College concerned must upload the marks awarded by the Examiner on the University portal latest by 18.05.2026;
- In case due to any technical reason, if any awards could not be uploaded on the portal, the same may be sent to the Conduct Branch with separate covering letter mentioning therein the specific technical reason for not uploading the awards. Such awards must reach the Conduct Branch with justification latest by last date of uploading of awards i.e 18.05.2026;
- After uploading the Awards, **the Instt./Deptt./Colleges shall also submit External/Internal Practical Awards directly to the Asstt. Registrar/Deputy Registrar of the concerned Result Branches.** The Forwarding Memo/bills of External Practical Awards List (in original) duly/properly filled in all respects may be submitted to the Deputy Registrar (Conduct), M.D. University, Rohtak, within further seven days after last date of uploading duly countersigned by concerned Director/HOD/Principal the External Practical Awards i.e. latest by 25.05.2026;
- While submitting TA/DA Bills, the External Practical Examiner must be required to clearly mention their full name, designation with Grade Pay, Name of College, Contact no., Name of Course with Semester and Session and the same may be submitted to the Accounts Branch of the University directly;
- In case any Instt./Department/Colleges does not upload the external awards on the University Portal latest by 18.05.2026, the late fee will be levied w.e.f. 19.05.2026 as per University Rules, irrespective of the submission of original external awards in time;
- The Director/Heads/Principals concerned are also requested to ensure to supply the required details as mentioned below for the remuneration of external Practical examiners. It is mandatory to supply Beneficiary ID of Practical examiner for their remuneration. However, it is made clear that the Bills not received in the following format will not be entertained for the processing of payment of Practical Bills :-
