1. Firstly, the admissions shall be offered to the candidates on basis of entrance merit.
2. Secondly, the admission shall be offered to the candidates based on their Academic Merit who have already applied upto 28.06.2026 and did not appear in the Entrance Examination.
3. For Department of Food Technology, the fresh candidates (who applied on or upto 24.08.2026) shall be offered admission based on their Academic Merit.
