Subject: Clarification regarding admission under Multiple Entry and Multiple Exit Scheme of NEP 2020.

Sir/Madam,

In continuation to the letter No. AC-VI/2026/F-402/22814-23135 dated 19.08.2026 (copy enclosed) on the subject cited above, the following clarifications are hereby made with the approval of the competent authorities:

1. The admissions should be made as per MEME guidelines (copy enclosed) and the admissions will be made on all UG and PG Programs except those governed by regulatory bodies like NCTE, AICTE, BCI, PCI, RCI, Council of Architecture etc.
2. While counting total seats to be offered for admission under these guidelines, a total of 10% supernumerary seats of the sanctioned seats of 1st year UG/PG programs and the vacant seats due to non-admission in 1st year of UG/PG as well as left over seats after PG 1st/2nd year/3rd year in the preceding year (2025-26) under NEP-2020 may be made.
3. The admissions in the affiliated Colleges/Institutes on these seats shall be done by their own level as per schedule notified vide letter dated 19.08.2026
4. For UTDs/Institutes, the University will display the total number of seats as per reservation policy on the University website and the admissions will be made by inviting the applications by the Head/Director at its own level as per format already circulated (file attached).
5. While conducting Counselling for admissions, the reservation policy be followed. In case, the seats remain vacant due to non-availability of reserved category applicants, the seats may be converted on the same day as per Govt. reservation policy.
6. As per Curriculum Structure already approved by the University, the applicants will be considered for admission to One Year PG Program (2nd year) in a specialization in which they have passed the UG (Hons. / Hons. with Research) under NEP 2020.
7. In the UTDs, the admissions on 10% supernumerary seats be considered only in those Programs which are currently being offered under NEP 2020 and seat matrix to be provided by the concerned Head/Director before 12.00 noon tomorrow.
8. The Registration Return of such admitted students will be filled online by the concerned Department/Institute/Centre as per the RR schedule for fresh students.

In the light of above the Vice-Chancellor has approved the following :

1. The application form (Annexure) for lateral entry in UG (2nd, 3d & 4th year) / PG (2nd year) programs against 10% supernumerary seats and vacant seats as per the provisions of MEME scheme mentioned under Table 2 of guidelines.

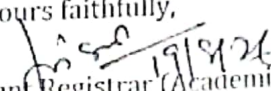

**MDU-REGULATIONS FOR ADMISSIONS UNDER
'MULTIPLE ENTRY MULTIPLE EXIT' (ME-ME) SCHEME OF NEP 2020**

The National Education Policy (NEP) 2020 envisages flexible learning and Innovative and adaptable curricular architecture that allows unique combinations of subjects, provides points of entry and exit, and eliminates the rigid barriers that are currently in place so that learners have the freedom to pursue their own academic paths. In addition, ME-ME will pave the way for seamless student mobility, between or within degree-granting HEIs through a formal system of credit recognition, credit accumulation, credit transfers, and credit redemption.

This regulation envisages freedom to the students to exit in between a program of study, for any reason,

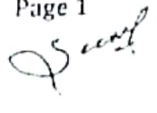
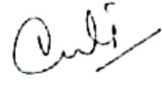
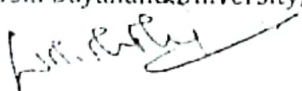
- and resume the Program later after availing break
- or continue the rest of the study in another HEI (Migration)
- or leave it altogether with an appropriate qualification.

1. OBJECTIVES:

- To provide flexibility to students from the curricular, pedagogic, and disciplinary boundaries of institutions, and enable a wider learning environment in the inter institutional context.
- To ensure learning is exploratory along with the flexibility to experiment and explore multiple avenues.
- To ensure that the 10% Supernumerary as well as vacant seats are filled up through a transparent admission process for lateral entry from NCrF level 5 onwards.
- To ensure mobility across disciplines and knowledge systems in a credible manner in accordance with the guiding principles of NEP 2020.

2. REQUIREMENTS FOR STUDENTS:

- Students should have a functional ABC ID or APAAR ID or any identification number so created or authorised to be created by the UGC/ Ministry of Education, and credentials are uploaded regularly on the ABC portal.
- Students, desiring to opt for entry into a level of study of a programme offered by a HEI* (such as Level 5/5.5/6/6.5), should fulfil the minimum eligibility criteria prescribed for initial admission to that programme of study (for instance, students



who wish to enter into the second year of four-year undergraduate degree programme in another HEI, after completing the first year of such programme in his/her parent HEI, should fulfil the minimum eligibility criteria prescribed for admission to the first year of such programme of that HEI where he/she intends to enter).

- The awarded credits are recorded and documented in the individual's academic record or transcript, indicating the specific courses or modules for which credit has been granted.
- The student should check the websites of HEIs and shortlist the HEIs where he/she seek to avail entry under ME-ME and apply as per the procedure prescribed by such HEIs.

3. SUMMARY OF ENTRY AND EXIT POINTS

NEP 2020 clearly specifies the entry and exit points in the academic programmes offered in the higher education institutions. Based on NCf and NHEQF, a summary of entry and exit points in the undergraduate and postgraduate programmes is provided below:

4. ADMISSIONS UNDER MULTIPLE ENTRY MULTIPLE EXIT (ME-ME)

The student can take admission under ME-ME from 3rd semester onwards as under:

- a) resuming the Program later after availing break (after exit in between a program of study, for any reason) as outlined in Table - 2
- b) continuing the program without availing break from one HEI to another HEI (MDU or its affiliated colleges)

The admissions under ME-ME are based on Academic Equivalence as under:

- i) Direct Assessment based on relevant award (Certificate/Diploma/PG Diploma /UG Degree) as mentioned in Table 1.
- ii) Based on completion of additional/bridge courses that a student needs to undertake to earn an award (Certificate/Diploma/PG Diploma /UG Degree) as recommended by the 'Equivalence Committee for ME-ME'.

5. ADMISSION CUM EQUIVALENCE COMMITTEE FOR ME-ME

The composition of Admission cum Equivalence Committee to consider the case of lateral admissions under ME-ME scheme is as under:

1. Head/Director of UTD/Centre/Institute or Principal/Director of affiliated College/Institute
2. Three faculty members of concerned Department/Discipline

The decision of an institute to allow entry or otherwise, under the ME-ME should be based on objective criteria, providing a fair and equal opportunity to every applicant. However, entry into another institution, after exiting from the institution where a student is originally enrolled, is not a matter of right. The institution, where entry is sought, may reject the transfer or recommend bridge courses to fill the gaps, if any, while accepting the request for entry based on the recommendation of equivalence committee.

6. OPERATIONAL GUIDELINES

Lateral entry admissions for students who exit after completion of Certificate/Diploma/PG Diploma in an Institute/University into the 2nd/3rd year of UG/PG Programs offered under NEP 2020 will be made in line with UGC Curriculum and Credit Framework for UG/PG Programs as per the following provisions:

1. There should be a provision of 10% supernumerary seats in Programs (except programs offered under the control of regulatory bodies like BCI/PCI/AICTE/NCTE etc.) for lateral entry by following State Reservation Policy to accommodate the students who wish to

- take admission through ME-ME provision as per UGC Curriculum and Credit Framework for UG/PG Programs. The applications for lateral entry admission in UTD/affiliated colleges should be invited in the prospectus along with counselling schedule.
2. Students seeking lateral entry should have a Certificate/Diploma/PG Diploma with equivalent credits as per the UGC curriculum and credit framework of UG/PG Programs (minimum 40 credits per year i.e. 20 credits per semester) including core, minor, multidisciplinary, value added, Ability Enhancement and skill enhancement courses.
 3. a). A student may be allowed to complete the deficient courses including internship (as identified by the equivalence committee) through online/offline mode through self study and counselling support available in the University/its affiliated colleges or may complete the courses in regular mode along with current students of relevance class.
b). Equivalence Committee may exempt the students to repeat a course in relevant semester which he/she has already completed and awarded credit thereof.
 4. A student may be allowed to complete an alternative course through offline/online mode if he/she has already completed the course in his/her 1st/2nd/3rd year of UG Program (from a HEI where the student has taken exit) which is offered at 2nd/3rd/4th year of UG Program of a HEI where the student wish to make Lateral Entry. This will avoid the repetition of the same course by the student.
 5. If a student opts for a change of discipline (multi disciplinary to single major), he/she shall be allowed only for lateral entry in the third semester of UG Program. However, the UTD/affiliated colleges receiving the discipline change request may consider/deny it depending on the availability of the resources.
 6. All credit redemptions shall be made through Academic Bank of Credit (ABC).
 7. The admissions through lateral entry shall be made on academic merit.
 8. The operational guidelines for ME-ME are summarized in Table 2. The maximum duration for UG Program is Seven years as per UGC Curriculum and Credit Framework.
 9. The Dean Academic Affairs is authorized to issue clarifications if any, under the above provisions of NEP 2020.
