9. Ratification of the action taken by the Vice-Chancellor, in anticipation of approval of the Academic Council, in approving promotion of Ms. Diksha & Ms. Sarita in M.A. (Geography) 3<sup>rd</sup> Semester for the session 2025-26.

Ms. Diksha & Ms. Sarita submitted applications on 22.07.2025 stating that they were admitted in M.A. (Geography) in the year 2023 and appeared in practical examination of the 2<sup>nd</sup> Semester but did not appear in the theory examination due to shortage of attendance. Both the candidates expressed their intent to continue their studies and seek admission in M.A. (Geography) 3<sup>rd</sup> Semester.

On the basis of the comments supplied by the R&S Branch as well as Result-I Branch and to avoid any potential litigation, the Vice-Chancellor allowed promotion to both the candidates to M.A. (Geography) 3<sup>rd</sup> Semester for the session 2025-26 in anticipation of the approval of Academic Council and the HOD (Geography) was informed, in this regard, vide letter dated 12.08.2025. Further, the Vice-Chancellor also constituted a Committee to fix the responsibility for lapses with regard to detained students, action required by all concerned and also to suggest measures to prevent such occurrence in future. A meeting of the Committee was held on 28.08.2025 and made the recommendations (**Annexure A/11 pages 218-219, already circulated**).

The Vice-Chancellor approved the recommendations of the Committee made in its meeting dated 28.08.2025 except Resolution No.1 as the then HoD had already retired and the necessary instructions with regard to Resolution No.2&3 have been issued vide letter dated 01.12.2025.

The Academic Council considered the above; and

**RESOLVED THAT THE ACTION TAKEN BY THE VICE-CHANCELLOR AS ABOVE BE RATIFIED. FURTHER THE DEPARTMENT BE COMMUNICATED TO BE CAREFUL IN FUTURE.**


