
**Eligibility Criteria for admission to M.Pharm. Programme:-**


The Chairman, BOS presented the recommendations of Departmental Committee held on 21-06-2020 regarding the eligibility conditions for admission to M.Pharm. based on the recent communication received from Pharmacy Council of India, New Delhi for consideration by BOS. The BOS deliberated over and approved the following eligibility conditions for M.Pharm. admission for session 2020-21.


- B.Pharm. with at least 55% marks in aggregate or any other examination recognized by M.D. University, Rohtak as equivalent thereto, and must possess a qualified and valid GPAT score. In case GPAT qualified students are not available and the seats remain vacant then the seats will be filled up on the basis of merit of B.Pharm. Marks (Aggregate).
- There shall be a relaxation in pass percentage from 55% to 50% (aggregate of four years of B.Pharm.) for SC/ST candidates and for candidates having not less than 05 years professional experience (after passing B. Pharm. course).
- The reservation policy of Government of Haryana shall be applicable.


The BOS forwarded the same for further consideration of Faculty of Pharmaceutical Sciences.




