The Committee discussed the various matters relating to admissions in detail and the following decisions were taken unanimously:-

- 1. Considered the request received from the representatives of the students' organization for increase of seats in the University Teaching Departments during session 2018-19. After detailed deliberation, it was decided that such requests be routed through concerned HOD's after being discussed in Departmental Committees, keeping in view the infrastructure available in the departments & other relevant factors (Except the courses being run under the purview of AICTE, NCTE, BCI & PCI).
- 2. The Committee considered the request of HOD (Pub. Admn.) for increase of seats in MA (Pub. Admn.) 5-year course under SFS from 30 to 40. The matter was discussed in detailed by the Committee keeping in view the data of last 3 years for filling up the seats of the courses as supplied by the HOD and resolved that the seats may be increased 30 to 50 for the session 2018-19 only in anticipation of approval of Admission Committee.
- 3. The committee considered the position of vacant seat in the following programmes as supplied by the Director, IHTM:-
