Special Chance for LLB 3 Year/ 5 Year (Semester System of regular students) to clear the degree.

Dear Sir/Madam.

On the request of the students, the Vice-Chancellor has accorded permission for grant of special chance to all Eligible students of LLB 3 Year/ 5 Year (Semester System only of regular students), who enrolled themselves for these courses in LLB 3 Year from 2007 to 2012 and in LLB 5 Year from 2007 to 2010 and could not clear the degree within the admissible chances. This special chance shall be admissible to the students, fulfilling the following conditions/ criteria :-

- 1. The special chance shall be strictly admissible to those students whose all admissible chances have been exhausted and not for improvement of marks/division.
- 2. The special chance shall be admissible to the students of LLB 3 Year (semester system only) who enrolled themselves from 2007 to 2012 and for LLB 5 Year (semester system only) from 2007 to 2010.
- 3. For this special chance, a fee of Rs. 10000 /- for each semester (depending upon the scheme of examinations), shall be chargeable.
- 4. The special chance is admissible to complete the Degree for the students only who have reappear in one or more papers.
- 5. For this special chance, Centre(s) of examinations shall be at Rohtak only.
- 6. The examination, for this special chance shall be got conducted tentatively in the month of July 2018 as per the existing/current syllabi, according to each course.

The examination form along with fee shall be filled up through online mode latest by 15.06.2018 from the portal of concerned college/department/institute where he/she get themselves enrolled. No examination form shall be entertained/ accepted after the cut-off date i.e. 15.06.2018. The schedule of examination/declaration of result will depend on the administrative requirements and the students will have no claim for early conduct of examination as well as declaration of result. If any INELIGIBLE candidate submits his/her online examinations form, he/she will be responsible for that and the examination fee will not be refunded to such students.
