3. Academic Audit Analysis for the Session 2013-14

The Academic Audit Reports of the University Teaching Departments were put before the Quality Advisory Council for the session 2013-14 by the Office of IQAC. On the basis of the Academic Audit Reports, the Council suggested the following:

- The faculty members should be motivated to get more projects from various funding agencies.
- There is a short of regular faculty in some of the departments and the recruitment of regular faculty may be made at the earliest.
- Though in some of the Academic Audit reports it has been recommended that there should be a Departmental Library, the Council is of the view that the Central Library is in the vicinity of all the departments and has a rich collection of books of all the subjects and hence the Central Library may be more strengthened.
- There needs to be a Language Lab in the Department of Hindi.
- For the Departments under the Faculty of Life Sciences, the budget for chemicals needs to be increased.
- The Council observed that there is lot of space in the University for departments. However, for some of the departments there is a need to provide/construct more class rooms/lecture theatres.

4. Any Other Item

The members of the QAC suggested the following for the next academic session i.e. 2016-17:

- i. Appreciating the efforts made by the University to sensitize the Teachers of the University regarding Choice Based Credit System, the QAC strongly put forth its view point that the CBCS be implemented in the University in ensuing academic session. It also suggested that orientation programmes for students be conducted to counsel the students for choosing the elective papers.
- ii. The faculty members be encouraged to bring more research projects from different funding agencies.
- iii. The alumni database needs to be more strengthened to utilize it for development of the University and job placement of students.
- iv. The Central Instrumentation Laboratory be strengthened by creating physical infrastructure.

Meeting ended with a vote of thanks to the chair.
