Sir/madam,

I am directed to inform you that the Committee under the Chairmanship of Dean, Academic Affairs, of its meeting held on 21.06.2018 recommended that improvement in the following programmes be allowed for old or new students within total span of programme.

Accordingly, the Vice-Chancellor under section 9-A(5) of M.D.U. Act has approved the recommendations of the Committee and the amendment in the Ordinances of relevant programmes is made as under:

Existing	Amended
LL.B 3 year (clause - 12)	
(i) A candidate who fails to pass or having been eligible, fails to appear in any semester examination will be allowed to clear the re-appear(s) and also for improvement of result after passing a semester examination within a period of six years. While re-appearing to pass a semester examination, the candidate will be exempted from re-appearing in the papers /practicals in which he/she has secured 40% pass marks.	xxx xxx xxx
Note: Improvement in LL.B. 3 year course is not allowed.	Improvement be allowed for old and new students within total span of programme.

LL.B 5 year (clause - 18)			
After passing each semester examination, a candidate will be allowed to appear for improvement of result in one or more theory papers only once within the period prescribed in clause-13 (i). Only improved marks (higher score) will be taken into account. The candidate will have to appear according to the current syllabus.	xxx	xxx	xxx
Note: Improvement in law subjects of B.A.LL.B.(Hons.)/B.B.A.LL.B. (Hons.) course is not allowed. However, improvement in pre-law subjects only is allowed in these courses.	Improvement be allowed for old and new students within total span of programme.
