PROCEEDINGS OF THE MEETING OF THE COMMITTEE TO CONSIDER THE DEMAND OF THE STUDENTS WITH REGARD TO PROMOTION RULES FOR 5 YEARS INTEGRATED PROGRAMME HELD ON 09.07.18 AT 03:00 P.M. IN THE OFFICE OF REGISTRAR, MAHARSHI DAYANAND UNIVERSITY, ROHTAK

In view of the request received from the students and Head, Department of Law, the Committee considered the following Clause-12 of the ordinance for all 5 years integrated courses already approved by the Academic Council/Executive Council and circulated by the Academic Branch vide letter No. AC-VI/17/F-17017-667 dated 17.07.17 to all concerned:-

## Common Ordinance for 5-Year Integrated Courses:

## **Proposed Amendment** Existing For promotion to 3<sup>rd</sup> semester, a student Clause-12 must have passed atleast 50% papers of The candidate shall be treated as 1<sup>st</sup> semester. For promotion to 5<sup>th</sup> promoted to the next semester/class semester, a student must have passed automatically subject to fulfilment of all papers of 1st semester. For promotion conditions as laid down in clause-9 of the to 7th semester, a student must have Ordinance. passed 1<sup>st</sup> module i.e. semester 1<sup>st</sup> to 6<sup>th</sup>. However, promotion to 7<sup>th</sup> semester will be allowed only when he/she has cleared Students to the other semesters will be the 1<sup>st</sup> module (1<sup>st</sup> to 6<sup>th</sup> semesters). promoted automatically. However, this clause is subject to fulfilment of conditions as laid down in clause-9. Note: For the purpose of promotion, each theory and practical in any subject shall be considered as separate paper.

The Committee further recommends that these amendments may be made applicable to all the students (old as well as new).

After great deliberation, it was decided that the above said Clause be applicable to the new students only who will take admission in the first year of all 5 years integrated courses during the session 2018-19.
