Various issues related to admissions were discussed in detail and the Committee unanimously recommended as under:-:

 The Committee considered the request of a student namely, Ms. Shipra Dhankar who took admission in LLM programme in morning shift at M.D.U Centre for Professional & Allied Studies but now wants to shift in LLM Programme (evening shift) at M.D.U CPAS as she has been selected Delhi Judicial Services,2019.

The Committee resolved that the request of candidate in respect of shifting her admission from LLM morning shift to evening shift be allowed but she will attend classes as per requirement of the ordinance. Further she may get NOC from her authorities as per rules.

Considered the request of Director, MERI College, Asoda, Delhi Global Institute of Management (Law College) Jasana, Faridabad and South point Degree College Sonipat in respect of extend the date of admission for BBA, LLM evening and B.A courses.

The Committee reiterates its earlier stand as taken in its meeting held on 14.09.2019 that no fresh admissions be made in the Departments/Colleges after 31.08.2019 as per instructions of the State Government even if seats remain vacant. The request of colleges be considered from the next session i.e. 2020-21. As at this belated stage, fresh admissions may not be allowed. Further resolved that the college branch should obtain the admission schedule before the processing affiliation for new courses/increase in section in intake.

- 3. Committee considered the recommendation of the P.G. Board of studies in Psychology that M.Phill programme in Psychology be discontinued from the session 2019-20 and resolved that the recommendation of P.G Board of Studies be considered from the next academic session after getting the fresh information from the Department of Psychology.
- 4. Committee considered the issue in respect of cut off date for admission in respect of foreign candidates and resolved that the last date for admission in respect of foreign candidates be extended upto 10.10.2019 with late fee of Rs. 2500/-.
