**Sub: Change of Nomenclature of B.Ed. Spl. Education (M.R.) to B.Ed. Spl. Education (Intellectual Disability) w.e.f the session 2020-21 in anticipation approval of the Academic/Executive Council of the University.**

Sir/Madam,

It is stated that the Central Body i.e. Rehabilitation Council of India, New Delhi vide its Circular bearing File No. 3-1/MR/11-RCI dated 24-07-2019 has intimated that as per Clause (zc) section 2, specified disability notified in the schedule of the RPwD Act, 2016, the term Mental Retardation has been replaced with Intellectual Disability and accordingly decided that the term Mental Retardation use in the syllabus of R.C.I. approved diploma, Degree and Masters level programmes be replaced with Intellectual Disability with immediate effect and it has been advised to all the RCI's approved training Institute conducting any programme in the field of Mental Retardation to take cognizance of the said decision of the council and incorporate necessary changes, wherever applicable (copy enclosed).

The said circular has been considered by the Vice-Chancellor, who has been pleased, to allow to change the nomenclature of B.Ed. Special Education (M.R.) to B.Ed. Spl. Education (Intellectual Disability) w.e.f. the session 2020-21 in anticipation
