Sub: Regarding equivalency of ITI qualification for admission to higher education.

Sir.

It is intimated that as per point no. 13 of the 'Important Notes' at page 2 of the Recognition/Equivalence list-April 2018 that all the examinations of various Boards etc. upto 10+2 Classes which are recognized by the Board of School Education Haryana, Bhiwani are recognized by this University.

Now the Board of School education, Haryana, Bhiwani has considered and approved that Diploma passed out through ITI are equivalent to Senior Secondary level examination and same has been uploaded on the website of Board of School Education, Haryana, Bhiwani i.e. (http://www.bseh.org.in) which are as under:-

"Minimum two years diploma courses after qualifying Secondary examination and also qualifying Hindi or English of Senior Secondary examination as an additional subject from Board of School Education Haryana Bhiwani.

Minimum one year diploma courses after qualifying Secondary examination (With one year Apprenticeship Certificate issued by Skill Development & Industrial Training Department, Haryana, Panchkula) and also qualifying Hindi or English of Senior Secondary examination as an additional subject from Board of School Education Haryana Bhiwani".

Further, it is intimated that matter has been considered by the Vice-Chancellor and passed orders that above eligibility conditions he be included in the Recognition/Equivalence List with the modification these may be applicable on such higher courses that do not warrant qualifications in some specific subjects like Medical Courses, Engineering Courses and some others that require PCB (Physics, Chemistry and Biology) and PCM. (Physics, Chemistry and Mathematics) etc.

Further necessary action may be taken accordingly.
