Following decisions were taken in the meeting unanimously:

- Moot Court Viva-Voce: It is resolved that the Moot Court Viva-Voce examination in B.A.LL.B (Hons.)-5 Year Course (10<sup>th</sup> Sem) and LL.B (Hons.)-3 Year Course (6<sup>th</sup> Sem) will be held online in the Department as well as affiliated Colleges in this session. The guidelines for colleges were issued by the Department in this regard (Copy attached).
- 2. Online Classes: It was resolved that the classes of forthcoming semesters (Except new admission) will be held from 01<sup>st</sup> August, 2020 online.
- 3. Admission Committee: It was resolved that the admission committee for new admission to verify the application forms for the session 2020-21 was constituted. Convenor of the committees are as under:
  - a) B.A.LL.B (Hons.)-5 Year Course Dr. Jitender Singh Dhull
  - b) LL.B (Hons.)-3 Year Course Dr. Anju Khanna
  - c) LL.M-2 Year (Shift-1&2) Dr. Neelam Kadyan
  - d) P.G. Diploma Courses Dr. Pratima Devi
     All the teachers of the Department are the members of admission committee.

- 4. Supernumerary Seats in Law Courses: It was resolved that in the following categories, supernumerary seats be created:
  - a) For Sports
  - b) For Cultural Activities
  - c) Foreign Students
  - d) NRI
  - e) Single Girl Child

Further, as per sports category, criterian as mentioned on page no. 33 of Prospectus 2019-20 needs a revision. This can be deliberated on following points:

- For 5 year course, no criterion explaining outstanding sportsperson is given. A
  student 17 years who has completed 12<sup>th</sup> doesn't come under these criterions. As
  there is no mention of Junior/Sub-Junior Championship or any other game
  recognized by AIU.
- 2. AIU rules do not allow a sportsperson to play Inter University after 25 years of age. We give admission to the outstanding sportsperson play for the university and on Page No. 34 of Prospectus 2019-20, the rule (xi) relates to the age 28 years. It was suggested in the Departmental Committee, this age can be decreased by 8 years i.e. 20 years for the student to take admission in B.A.LL.B-5 years course.
