Sub: Matter regarding grant of Permanent NOC to Self Financed Degree Colleges

Sir,

Kindly refer to your D.O letter No 9/21-2016-C-II(2) dated 30.12.2016 regarding reviewing of the policy of Provisional NOC to SFS Degree Colleges in the State of Haryana and to obtain permanent NOC which has been considered as mandatory as per decision taken and conveyed vide above referred D.O letter.

The D.O Letter under reference was considered and in terms of orders passed by the University authorities, the Principals all the SFS Degree Colleges affiliated with this University vide letter no CB-XIV/2017/Misc/1589-1628 dated 6.2.2017 were requested to obtained Permanent NOC of the State Govt which was granted as temporary NOC by your office and was only for a limited period and to initiate the process regarding obtaining the Permanent NOC from your office immediately, failing which admissions in these colleges would not be allotted w.e.f. the session 2017-18 and no further affiliation for introduction of additional seats in any UG/PG Course/Subject would be granted as per directions issued by your office vide DO letter under reference. A copy of the said letter was also sent to you vide letter Ends no CB-1 & CB-XIV/2017/Misc/1629-30 dated 6.2.2017 (copy enclosed)

The SFS Degree Colleges afflied with this university (list of which is enclosed at Annexure-I) have not sought/submitted the Permanent NOC of the State Govt. and are still gross deficient and as per decision conveyed by you vide D.O letter under reference no admissions were to be made in the colleges who failed to seek permanent NOC and University were also directed not to grant further affiliation to such colleges for introduction of additional UG/PG Course/subject . In compliance with these directions of the State Govt. no further affiliation to SFS Colleges who have failed to submit Permanent NOC of the State Govt was granted by this University. However, in place of placing these colleges under no admission category or with drawing Provisional NOC, the State Govt itself not making compliance of its own directions and making online admission in these colleges every years and might have not yet withdrawn the Provisional NOC of these Colleges.
