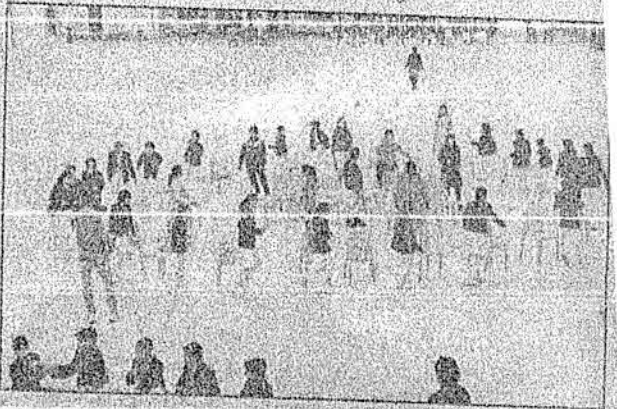

ED attaches ₹2.4 crore assets in JKCA for embezzlement

 The Enforcement Directorate (ED) has issued a provisional attachment order under the Prevention of Money Laundering Act (PMLA) to seize assets worth Rs 2.6 crore in a case pertaining to alleged embezzlement of funds of the Jammu and Kashmir Cricket Association (JKCA).
 Officials in the agency said the attachment order was issued under the PMLA against former treasurer of the JKCA Ahsan Ahmad Mirza and its finance committee member Mir Mansoor Gazanffer. Former Jammu and Kashmir Chief Minister and National Conference president Farooq Abdullah, who is presently in detention under the Public Safety Act (PSA), was earlier questioned by the ED in the case.
 Giving details of the attachments, the ED in a statement said, "They consist of three FDRs (fixed deposit receipts) totalling Rs 1.29 crore with J&K Bank branch in Lajpat Nagar, New Delhi, in the name of Mirza Sons, a partnership firm of Mirza and his father, and 11 kanals of land with structure and commercial shopping complex at Pandrethan, Srinagar, worth Rs 1.31 crore." The ED took up the case following an FIR by the CBI in the case in which the latter probe agency booked former office-bearers of the JKCA, including general

secretary Mohammad Khan and Mirza. The CBI later chargesheet against Abdullah, Khan, Manzoor Gazanffer, Ahmad Misgar and Ahmad Beigh accountant of the Jammu and Kashmir "misappropriation of funds amounting to Rs 2.4 crore" from grants received from the Board of Control for Cricket in India (BCCI) to the Jammu and Kashmir Cricket Association for promoting the game in the state between 2005-2006 to 2011-2012. The ED said its probe into the case started in December 2011 when it received Rs 94.08 crore from the BCCI in three different accounts. "However, other bank accounts opened in the name of JKCA into which these were transferred and several other bank accounts were transferred and several other bank accounts along with existing bank accounts later used for laundering of the JKCA," it has alleged.
 The ED has alleged that Mirza transferred huge amount from his personal bank account and then these amount were further transferred or drawn in cash. "Out of Rs 94.08 crore, Rs 1.31 crore was received by Mirza, who was a member of the finance committee of JKCA between 2006 and 2011 and the committee was illegally constituted by Farooq Abdullah, the then president of the JKCA," it charged
